## SOLUTIONS TO CONCEPTS

## CHAPTER 17

1. Given that, $400 \mathrm{~m}<\lambda<700 \mathrm{~nm}$.

$$
\begin{aligned}
& \frac{1}{700 \mathrm{~nm}}<\frac{1}{\lambda}<\frac{1}{400 \mathrm{~nm}} \\
\Rightarrow & \left.\frac{1}{7 \times 10^{-7}}<\frac{1}{\lambda}<\frac{1}{4 \times 10^{-7}} \Rightarrow \frac{3 \times 10^{8}}{7 \times 10^{-7}}<\frac{\mathrm{c}}{\lambda}<\frac{3 \times 10^{8}}{4 \times 10^{-7}} \text { (Where, } \mathrm{c}=\text { speed of light }=3 \times 10^{8} \mathrm{~m} / \mathrm{s}\right) \\
\Rightarrow & 4.3 \times 10^{14}<\mathrm{c} / \lambda<7.5 \times 10^{14} \\
\Rightarrow & 4.3 \times 10^{14} \mathrm{~Hz}<\mathrm{f}<7.5 \times 10^{14} \mathrm{~Hz} .
\end{aligned}
$$

2. Given that, for sodium light, $\lambda=589 \mathrm{~nm}=589 \times 10^{-9} \mathrm{~m}$
a) $f_{a}=\frac{3 \times 10^{8}}{589 \times 10^{-9}}=5.09 \times 10^{14} \sec ^{-1}\left[\because f=\frac{c}{\lambda}\right]$
b) $\frac{\mu_{\mathrm{a}}}{\mu_{\mathrm{w}}}=\frac{\lambda_{\mathrm{w}}}{\lambda_{\mathrm{a}}} \Rightarrow \frac{1}{1.33}=\frac{\lambda_{\mathrm{w}}}{589 \times 10^{-9}} \Rightarrow \lambda_{\mathrm{w}}=443 \mathrm{~nm}$
c) $f_{w}=f_{a}=5.09 \times 10^{14} \sec ^{-1}$ [Frequency does not change]
d) $\frac{\mu_{a}}{\mu_{\mathrm{w}}}=\frac{\mathrm{v}_{\mathrm{w}}}{\mathrm{v}_{\mathrm{a}}} \Rightarrow \mathrm{v}_{\mathrm{w}}=\frac{\mu_{\mathrm{a}} \mathrm{v}_{\mathrm{a}}}{\mu_{\mathrm{w}}}=\frac{3 \times 10^{8}}{1.33}=2.25 \times 10^{8} \mathrm{~m} / \mathrm{sec}$.
3. We know that, $\frac{\mu_{2}}{\mu_{1}}=\frac{\mathrm{v}_{1}}{\mathrm{v}_{2}}$

So, $\frac{1472}{1}=\frac{3 \times 10^{8}}{v_{400}} \Rightarrow v_{400}=2.04 \times 10^{8} \mathrm{~m} / \mathrm{sec}$.
[because, for air, $\mu=1$ and $v=3 \times 10^{8} \mathrm{~m} / \mathrm{s}$ ]
Again, $\frac{1452}{1}=\frac{3 \times 10^{8}}{v_{760}} \Rightarrow v_{760}=2.07 \times 10^{8} \mathrm{~m} / \mathrm{sec}$.
4. $\mu_{\mathrm{t}}=\frac{1 \times 3 \times 10^{8}}{(2.4) \times 10^{8}}=1.25 \quad\left[\right.$ since, $\left.\mu=\frac{\text { velocity of light in vaccum }}{\text { velocity of light in the given medium }}\right]$
5. Given that, $\mathrm{d}=1 \mathrm{~cm}=10^{-2} \mathrm{~m}, \lambda=5 \times 10^{-7} \mathrm{~m}$ and $\mathrm{D}=1 \mathrm{~m}$
a) Separation between two consecutive maxima is equal to fringe width.

$$
\text { So, } \beta=\frac{\lambda D}{d}=\frac{5 \times 10^{-7} \times 1}{10^{-2}} \mathrm{~m}=5 \times 10^{-5} \mathrm{~m}=0.05 \mathrm{~mm} \text {. }
$$

b) When, $\beta=1 \mathrm{~mm}=10^{-3} \mathrm{~m}$

$$
10^{-3} \mathrm{~m}=\frac{5 \times 10^{-7} \times 1}{\mathrm{D}} \Rightarrow \mathrm{D}=5 \times 10^{-4} \mathrm{~m}=0.50 \mathrm{~mm}
$$

6. Given that, $\beta=1 \mathrm{~mm}=10^{-3} \mathrm{~m}, \mathrm{D}=2 . \mathrm{t} \mathrm{m}$ and $\mathrm{d}=1 \mathrm{~mm}=10^{-3} \mathrm{~m}$

So, $10^{-3} \mathrm{~m}=\frac{25 \times \lambda}{10^{-3}} \Rightarrow \lambda=4 \times 10^{-7} \mathrm{~m}=400 \mathrm{~nm}$.
7. Given that, $d=1 \mathrm{~mm}=10^{-3} \mathrm{~m}, \mathrm{D}=1 \mathrm{~m}$.

So, fringe with $=\frac{D \lambda}{d}=0.5 \mathrm{~mm}$.
a) So, distance of centre of first minimum from centre of central maximum $=0.5 / 2 \mathrm{~mm}=0.25 \mathrm{~mm}$
b) No. of fringes $=10 / 0.5=20$.
8. Given that, $\mathrm{d}=0.8 \mathrm{~mm}=0.8 \times 10^{-3} \mathrm{~m}, \lambda=589 \mathrm{~nm}=589 \times 10^{-9} \mathrm{~m}$ and $\mathrm{D}=2 \mathrm{~m}$.

So, $\beta=\frac{\mathrm{D} \lambda}{\mathrm{d}}=\frac{589 \times 10^{-9} \times 2}{0.8 \times 10^{-3}}=1.47 \times 10^{-3} \mathrm{~m}=147 \mathrm{~mm}$.
9. Given that, $\lambda=500 \mathrm{~nm}=500 \times 10^{-9} \mathrm{~m}$ and $\mathrm{d}=2 \times 10^{-3} \mathrm{~m}$

As shown in the figure, angular separation $\theta=\frac{\beta}{D}=\frac{\lambda D}{d D}=\frac{\lambda}{d}$
So, $\theta=\frac{\beta}{D}=\frac{\lambda}{d}=\frac{500 \times 10^{-9}}{2 \times 10^{-3}}=250 \times 10^{-6}$
$=25 \times 10^{-5}$ radian $=0.014$ degree .

10. We know that, the first maximum (next to central maximum) occurs at $y=\frac{\lambda D}{d}$

Given that, $\lambda_{1}=480 \mathrm{~nm}, \lambda_{2}=600 \mathrm{~nm}, \mathrm{D}=150 \mathrm{~cm}=1.5 \mathrm{~m}$ and $\mathrm{d}=0.25 \mathrm{~mm}=0.25 \times 10^{-3} \mathrm{~m}$
So, $\quad y_{1}=\frac{D \lambda_{1}}{d}=\frac{1.5 \times 480 \times 10^{-9}}{0.25 \times 10^{-3}}=2.88 \mathrm{~mm}$

$$
\mathrm{y}_{2}=\frac{1.5 \times 600 \times 10^{-9}}{0.25 \times 10^{-3}}=3.6 \mathrm{~mm}
$$

So, the separation between these two bright fringes is given by,
$\therefore$ separation $=\mathrm{y}_{2}-\mathrm{y}_{1}=3.60-2.88=0.72 \mathrm{~mm}$.
11. Let $\mathrm{m}^{\text {th }}$ bright fringe of violet light overlaps with $\mathrm{n}^{\text {th }}$ bright fringe of red light.
$\therefore \frac{\mathrm{m} \times 400 \mathrm{~nm} \times \mathrm{D}}{\mathrm{d}}=\frac{\mathrm{n} \times 700 \mathrm{~nm} \times \mathrm{D}}{\mathrm{d}} \Rightarrow \frac{\mathrm{m}}{\mathrm{n}}=\frac{7}{4}$
$\Rightarrow 7^{\text {th }}$ bright fringe of violet light overlaps with $4^{\text {th }}$ bright fringe of red light (minimum). Also, it can be seen that $14^{\text {th }}$ violet fringe will overlap $8^{\text {th }}$ red fringe.
Because, $m / n=7 / 4=14 / 8$.
12. Let, $\mathrm{t}=$ thickness of the plate

Given, optical path difference $=(\mu-1) t=\lambda / 2$
$\Rightarrow t=\frac{\lambda}{2(\mu-1)}$
13. a) Change in the optical path $=\mu t-t=(\mu-1) t$
b) To have a dark fringe at the centre the pattern should shift by one half of a fringe.

$$
\Rightarrow(\mu-1) t=\frac{\lambda}{2} \Rightarrow t=\frac{\lambda}{2(\mu-1)}
$$

14. Given that, $\mu=1.45, \mathrm{t}=0.02 \mathrm{~mm}=0.02 \times 10^{-3} \mathrm{~m}$ and $\lambda=620 \mathrm{~nm}=620 \times 10^{-9} \mathrm{~m}$

We know, when the transparent paper is pasted in one of the slits, the optical path changes by $(\mu-1)$ t.
Again, for shift of one fringe, the optical path should be changed by $\lambda$.
So, no. of fringes crossing through the centre is given by,
$\mathrm{n}=\frac{(\mu-1) \mathrm{t}}{\lambda}=\frac{0.45 \times 0.02 \times 10^{-3}}{620 \times 10^{-9}}=14.5$
15. In the given Young's double slit experiment,
$\mu=1.6, \mathrm{t}=1.964$ micron $=1.964 \times 10^{-6} \mathrm{~m}$
We know, number of fringes shifted $=\frac{(\mu-1) \mathrm{t}}{\lambda}$
So, the corresponding shift $=$ No.of fringes shifted $\times$ fringe width

$$
\begin{equation*}
=\frac{(\mu-1) t}{\lambda} \times \frac{\lambda D}{d}=\frac{(\mu-1) t D}{d} \tag{1}
\end{equation*}
$$

Again, when the distance between the screen and the slits is doubled,

$$
\begin{equation*}
\text { Fringe width }=\frac{\lambda(2 \mathrm{D})}{\mathrm{d}} \tag{2}
\end{equation*}
$$

From (1) and (2), $\frac{(\mu-1) t D}{d}=\frac{\lambda(2 D)}{d}$
$\Rightarrow \lambda=\frac{(\mu-1) \mathrm{t}}{\lambda}=\frac{(1.6-1) \times(1.964) \times 10^{-6}}{2}=589.2 \times 10^{-9}=589.2 \mathrm{~nm}$.
16. Given that, $\mathrm{t}_{1}=\mathrm{t}_{2}=0.5 \mathrm{~mm}=0.5 \times 10^{-3} \mathrm{~m}, \mu_{\mathrm{m}}=1.58$ and $\mu_{\mathrm{p}}=1.55$, $\lambda=590 \mathrm{~nm}=590 \times 10^{-9} \mathrm{~m}, \mathrm{~d}=0.12 \mathrm{~cm}=12 \times 10^{-4} \mathrm{~m}, \mathrm{D}=1 \mathrm{~m}$
a) Fringe width $=\frac{D \lambda}{d}=\frac{1 \times 590 \times 10^{-9}}{12 \times 10^{-4}}=4.91 \times 10^{-4} \mathrm{~m}$.
b) When both the strips are fitted, the optical path changes by $\Delta x=\left(\mu_{m}-1\right) t_{1}-\left(\mu_{p}-1\right) t_{2}=\left(\mu_{m}-\mu_{p}\right) t$ $=(1.58-1.55) \times(0.5)\left(10^{-3}\right)=0.015 \times 10^{-13} \mathrm{~m}$.
So, No. of fringes shifted $=\frac{0.015 \times 10^{-3}}{590 \times 10^{-3}}=25.43$.
$\Rightarrow$ There are 25 fringes and 0.43 th of a fringe.
$\Rightarrow$ There are 13 bright fringes and 12 dark fringes and 0.43 th of a dark fringe. So, position of first maximum on both sides will be given by
$\therefore x=0.43 \times 4.91 \times 10^{-4}=0.021 \mathrm{~cm}$

$$
\left.x^{\prime}=(1-0.43) \times 4.91 \times 10^{-4}=0.028 \mathrm{~cm} \text { (since, fringe width }=4.91 \times 10^{-4} \mathrm{~m}\right)
$$


17. The change in path difference due to the two slabs is $\left(\mu_{1}-\mu_{2}\right) t$ (as in problem no. 16).

For having a minimum at $P_{0}$, the path difference should change by $\lambda / 2$.
So, $\Rightarrow \lambda / 2=\left(\mu_{1}-\mu_{2}\right) t \Rightarrow t=\frac{\lambda}{2\left(\mu_{1}-\mu_{2}\right)}$.
18. Given that, $\mathrm{t}=0.02 \mathrm{~mm}=0.02 \times 10^{-3} \mathrm{~m}, \mu_{1}=1.45, \lambda=600 \mathrm{~nm}=600 \times 10^{-9} \mathrm{~m}$
a) Let, $I_{1}=$ Intensity of source without paper $=1$
b) Then $I_{2}=$ Intensity of source with paper $=(4 / 9)$ I
$\Rightarrow \frac{I_{1}}{I_{2}}=\frac{9}{4} \Rightarrow \frac{r_{1}}{r_{2}}=\frac{3}{2}$ [because $I \propto r^{2}$ ]
where, $r_{1}$ and $r_{2}$ are corresponding amplitudes.
So, $\frac{I_{\text {max }}}{I_{\text {min }}}=\frac{\left(r_{1}+r_{2}\right)^{2}}{\left(r_{1}-r_{2}\right)^{2}}=25: 1$
b) No. of fringes that will cross the origin is given by,
$\mathrm{n}=\frac{(\mu-1) \mathrm{t}}{\lambda}=\frac{(1.45-1) \times 0.02 \times 10^{-3}}{600 \times 10^{-9}}=15$.
19. Given that, $\mathrm{d}=0.28 \mathrm{~mm}=0.28 \times 10^{-3} \mathrm{~m}, \mathrm{D}=48 \mathrm{~cm}=0.48 \mathrm{~m}, \lambda_{\mathrm{a}}=700 \mathrm{~nm}$ in vacuum

Let, $\lambda_{w}=$ wavelength of red light in water
Since, the fringe width of the pattern is given by,
$\beta=\frac{\lambda_{w} D}{d}=\frac{525 \times 10^{-9} \times 0.48}{0.28 \times 10^{-3}}=9 \times 10^{-4} \mathrm{~m}=0.90 \mathrm{~mm}$.
20. It can be seen from the figure that the wavefronts reaching $O$ from $S_{1}$ and $S_{2}$ will have a path difference of $\mathrm{S}_{2} \mathrm{X}$.
In the $\Delta S_{1} S_{2} X$,
$\sin \theta=\frac{S_{2} X}{S_{1} S_{2}}$
So, path difference $=S_{2} X=S_{1} S_{2} \sin \theta=d \sin \theta=d \times \lambda / 2 d=\lambda / 2$


As the path difference is an odd multiple of $\lambda / 2$, there will be a dark fringe at point $P_{0}$.
21. a) Since, there is a phase difference of $\pi$ between direct light and reflecting light, the intensity just above the mirror will be zero.
b) Here, $2 \mathrm{~d}=$ equivalent slit separation
$D=$ Distance between slit and screen.
We know for bright fringe, $\Delta x=\frac{y \times 2 d}{D}=n \lambda$
But as there is a phase reversal of $\lambda / 2$.
$\Rightarrow \frac{\mathrm{y} \times 2 \mathrm{~d}}{\mathrm{D}}+\frac{\lambda}{2}=\mathrm{n} \lambda$

$$
\Rightarrow \frac{\mathrm{y} \times 2 \mathrm{~d}}{\mathrm{D}}=\mathrm{n} \lambda-\frac{\lambda}{2} \Rightarrow \mathrm{y}=\frac{\lambda \mathrm{D}}{4 \mathrm{~d}}
$$


22. Given that, $\mathrm{D}=1 \mathrm{~m}, \lambda=700 \mathrm{~nm}=700 \times 10^{-9} \mathrm{~m}$

Since, $a=2 \mathrm{~mm}, \mathrm{~d}=2 \mathrm{a}=2 \mathrm{~mm}=2 \times 10^{-3} \mathrm{~m}$ (L loyd's mirror experiment)
Fringe width $=\frac{\lambda \mathrm{D}}{\mathrm{d}}=\frac{700 \times 10^{-9} \mathrm{~m} \times 1 \mathrm{~m}}{2 \times 10^{-3} \mathrm{~m}}=0.35 \mathrm{~mm}$.
23. Given that, the mirror reflects $64 \%$ of energy (intensity) of the light.

So, $\frac{l_{1}}{I_{2}}=0.64=\frac{16}{25} \Rightarrow \frac{r_{1}}{r_{2}}=\frac{4}{5}$
So, $\frac{I_{\text {max }}}{I_{\text {min }}}=\frac{\left(r_{1}+r_{2}\right)^{2}}{\left(r_{1}-r_{2}\right)^{2}}=81: 1$.
24. It can be seen from the figure that, the apparent distance of the screen from the slits is, $D=2 D_{1}+D_{2}$
So, Fringe width $=\frac{D \lambda}{d}=\frac{\left(2 D_{1}+D_{2}\right) \lambda}{d}$
25. Given that, $\lambda=(400 \mathrm{~nm}$ to 700 nm$), \mathrm{d}=0.5 \mathrm{~mm}=0.5 \times 10^{-3} \mathrm{~m}$, $\mathrm{D}=50 \mathrm{~cm}=0.5 \mathrm{~m}$ and on the screen $\mathrm{y}_{\mathrm{n}}=1 \mathrm{~mm}=1 \times 10^{-3} \mathrm{~m}$
a) We know that for zero intensity (dark fringe)
$y_{n}=\left(\frac{2 n+1}{2}\right) \frac{\lambda_{n} D}{d}$ where $n=0,1,2, \ldots \ldots$.

$\Rightarrow \lambda_{\mathrm{n}}=\frac{2}{(2 \mathrm{n}+1)} \frac{\lambda_{\mathrm{n}} \mathrm{d}}{\mathrm{D}}=\frac{2}{2 \mathrm{n}+1} \times \frac{10^{-3} \times 0.5 \times 10^{-3}}{0.5} \Rightarrow \frac{2}{(2 \mathrm{n}+1)} \times 10^{-6} \mathrm{~m}=\frac{2}{(2 \mathrm{n}+1)} \times 10^{3} \mathrm{~nm}$
If $\mathrm{n}=1, \lambda_{1}=(2 / 3) \times 1000=667 \mathrm{~nm}$
If $\mathrm{n}=1, \lambda_{2}=(2 / 5) \times 1000=400 \mathrm{~nm}$
So, the light waves of wavelengths 400 nm and 667 nm will be absent from the out coming light.
b) For strong intensity (bright fringes) at the hole

$$
y_{n}=\frac{\mathrm{n} \lambda_{\mathrm{n}} \mathrm{D}}{\mathrm{~d}} \Rightarrow \lambda_{\mathrm{n}}=\frac{\mathrm{y}_{\mathrm{n}} \mathrm{~d}}{\mathrm{nD}}
$$

When, $\mathrm{n}=1, \lambda_{1}=\frac{\mathrm{y}_{\mathrm{n}} \mathrm{d}}{\mathrm{D}}=\frac{10^{-3} \times 0.5 \times 10^{-3}}{0.5}=10^{-6} \mathrm{~m}=1000 \mathrm{~nm}$.
1000 nm is not present in the range $400 \mathrm{~nm}-700 \mathrm{~nm}$
Again, where $\mathrm{n}=2, \lambda_{2}=\frac{\mathrm{y}_{\mathrm{n}} \mathrm{d}}{2 \mathrm{D}}=500 \mathrm{~nm}$
So, the only wavelength which will have strong intensity is 500 nm .
26. From the diagram, it can be seen that at point $O$.

Path difference $=(A B+B O)-(A C+C O)$

$$
=2(A B-A C) \quad[\text { Since, } A B=B O \text { and } A C=C O]=2\left(\sqrt{d^{2}+D^{2}}-D\right)
$$

For dark fringe, path difference should be odd multiple of $\lambda / 2$.
So, $2\left(\sqrt{d^{2}+D^{2}}-D\right)=(2 n+1)(\lambda / 2)$
$\Rightarrow \sqrt{d^{2}+D^{2}}=D+(2 n+1) \lambda / 4$
$\Rightarrow D^{2}+d^{2}=D^{2}+(2 n+1)^{2} \lambda^{2} / 16+(2 n+1) \lambda D / 2$
Neglecting, $(2 n+1)^{2} \lambda^{2} / 16$, as it is very small


We get, $d=\sqrt{(2 n+1) \frac{\lambda D}{2}}$
For minimum ' $d$ ', putting $n=0 \Rightarrow d_{\text {min }}=\sqrt{\frac{\lambda D}{2}}$.
27. For minimum intensity
$\therefore \mathrm{S}_{1} \mathrm{P}-\mathrm{S}_{2} \mathrm{P}=\mathrm{x}=(2 \mathrm{n}+1) \lambda / 2$
From the figure, we get


Putting, $\mathrm{n}=0 \Rightarrow \mathrm{Z}=15 \lambda / 4 \quad \mathrm{n}=-1 \Rightarrow Z=-15 \lambda / 4$

$$
\mathrm{n}=1 \Rightarrow \mathrm{Z}=7 \lambda / 12 \quad \mathrm{n}=2 \Rightarrow \mathrm{Z}=-9 \lambda / 20
$$

$\therefore Z=7 \lambda / 12$ is the smallest distance for which there will be minimum intensity.
28. Since $S_{1}, S_{2}$ are in same phase, at $O$ there will be maximum intensity.

Given that, there will be a maximum intensity at $P$.
$\Rightarrow$ path difference $=\Delta x=n \lambda$
From the figure,
$\left(S_{1} P\right)^{2}-\left(S_{2} P\right)^{2}=\left(\sqrt{D^{2}+X^{2}}\right)^{2}-\left(\sqrt{(D-2 \lambda)^{2}+X^{2}}\right)^{2}$
$=4 \lambda D-4 \lambda^{2}=4 \lambda D\left(\lambda^{2}\right.$ is so small and can be neglected)
$\Rightarrow \mathrm{S}_{1} \mathrm{P}-\mathrm{S}_{2} \mathrm{P}=\frac{4 \lambda \mathrm{D}}{2 \sqrt{\mathrm{x}^{2}+\mathrm{D}^{2}}}=\mathrm{n} \lambda$
$\Rightarrow \frac{2 \mathrm{D}}{\sqrt{\mathrm{x}^{2}+\mathrm{D}^{2}}}=v$
$\Rightarrow \mathrm{n}^{2}\left(\mathrm{X}^{2}+\mathrm{D}^{2}\right)=4 \mathrm{D}^{2}=\Delta \mathrm{X}=\frac{\mathrm{D}}{\mathrm{n}} \sqrt{4-\mathrm{n}^{2}}$
when $\mathrm{n}=1, \mathrm{x}=\sqrt{3} \mathrm{D} \quad$ ( $1^{\text {st }}$ order)

$$
n=2, x=0 \quad\left(2^{\text {nd }} \text { order }\right)
$$

$\therefore$ When $X=\sqrt{3} D$, at $P$ there will be maximum intensity.
29. As shown in the figure,

$$
\begin{align*}
& \left(S_{1} P\right)^{2}=(P X)^{2}+\left(S_{1} X\right)^{2}  \tag{1}\\
& \left(S_{2} P\right)^{2}=(P X)^{2}+\left(S_{2} X\right)^{2} \tag{2}
\end{align*}
$$

From (1) and (2),
$\left(S_{1} P\right)^{2}-\left(S_{2} P\right)^{2}=\left(S_{1} X\right)^{2}-\left(S_{2} X\right)^{2}$ $=(1.5 \lambda+R \cos \theta)^{2}-(R \cos \theta-15 \lambda)^{2}$
$=6 \lambda R \cos \theta$
$\Rightarrow\left(\mathrm{S}_{1} \mathrm{P}-\mathrm{S}_{2} \mathrm{P}\right)=\frac{6 \lambda R \cos \theta}{2 R}=3 \lambda \cos \theta$.


For constructive interference,
$\left(S_{1} P-S_{2} P\right)^{2}=x=3 \lambda \cos \theta=n \lambda$
$\Rightarrow \cos \theta=n / 3 \Rightarrow \theta=\cos ^{-1}(n / 3)$, where $n=0,1,2, \ldots$.
$\Rightarrow \theta=0^{\circ}, 48.2^{\circ}, 70.5^{\circ}, 90^{\circ}$ and similar points in other quadrants.
30. a) As shown in the figure, $B P_{0}-A P_{0}=\lambda / 3$
